### **Membership Terms & Conditions**



### 1. Introduction

- These Terms & Conditions ("Terms") set out the rules of membership with the British Quality Foundation ("BQF").
- By applying for or renewing membership, you confirm that you have read, understood, and agree to these Terms.

### 2. Membership

### 2.1 Eligibility & Application

Membership is open to both organisations and individuals that support BQF's Vision, Purpose and Values, and who meet the criteria of their chosen membership package.

### 2.2 Membership Packages

Details of current packages and benefits are available on the BQF website. These may be updated from time to time.

### 2.3 Subscription & Payment

- Membership fees are set by the BQF Board.
- Membership runs for 12 months unless otherwise agreed.
- Membership certificate and logo will be issued on receipt of payment.
- Membership fees are non-refundable.

### 2.4 Renewal

- A renewal invoice or quotation will be issued at least one (1) month before the renewal date.
- Membership may be terminated if payment is not received by the due date.

### 2.5 Termination

- Members may resign by written notice either before the renewal date or within one (1) month of receiving a renewal notification, whichever is later.
- BQF may terminate membership if fees remain unpaid 30 days after a reminder, or if a member breaches these Terms or the Code of Conduct.
- Members remain responsible for any fees or costs incurred up to the termination date.

### 2.6 Group or Corporate Memberships

Where membership is purchased for an organisation, access to membership benefits is limited to employees of that organisation (verified by email address) and, where applicable, its agreed subsidiaries as confirmed in writing by BQF.

### 3. Member Responsibilities

### 3.1 Nominated Representative

Each member must appoint a representative to act as the main contact and promptly update BQF with any changes.
